# II. **ELIGIBILITY CRITERIA:**

Those candidates having qualifications equivalent to any of the prescribed qualifications should submit Equivalency Certificate issued by the Competent Authority and without such a certificate, their candidature will not be considered.

- III. <u>DURATION OF TRAINING:</u> The duration of Apprenticeship training will be for a period of one year as per Apprenticeship Act 1961. <u>Those who have undergone apprenticeship training in any other organization for any duration under the Apprenticeship Act 1961 are not eligible to apply.</u>
- IV. <u>MINIMUM PHYSICAL STANDARDS:</u> As prescribed in Clause 4 of the Apprenticeship Rule 1992, and amendments thereof if any.

# V. <u>SELECTION PROCEDURE:</u>

- **A.** Only candidates who have passed the prescribed qualification during the calendar year 2021,2022,2023, 2024 & 2025 and are domicile of West Bengal shall be considered. Short-listing of candidates for selection will be done based on the percentage of marks obtained in the basic prescribed qualification as applicable to the respective disciplines. In case, same percentage of marks is secured by more than one candidate in prescribed qualification, relative merit shall be decided based on seniority in passing year.
- **B.** Candidates short-listed for the certificate verification prior to selection should bring the original certificates towards proof of age, qualification, percentage of mark etc. and self-attested copies of all these certificates, for verification and their candidature shall be considered on the strength of the original certificates. In case of failure to produce the original certificates, the candidature shall be rejected.
- C. Those candidates who successfully complete certificate verification shall be provisionally considered for selection against the notified training seats in the order of merit, subject to medical fitness.
- VI. TRAVEL EXPENSES: No travel expenses are admissible during apprenticeship training period.
- VII. **BOARDING/LODGING:** Boarding or lodging will not be provided by Hooghly CSL during the apprenticeship training period.
- VIII. **APPLICATION FEE**: Nil.
